Included on the ACC Voter's Guide are races covering the U.S. Senate, the U.S. House of Representatives, Corporation Commission, and the Arizona State Senate and Arizona State House of Representatives. It is important to remember that members of the State Senate and State House are elected by legislative district. Each legislative district includes one State Senator and two State Representatives.

Arizona Catholic Conference Bishops' Statement Opposing the Legalization of Recreational Marijuana **Vote NO on Proposition 205**

The Bishops of the Arizona Catholic Conference oppose the campaign to legalwize the recreational use of marijuana in Arizona because it is harmful to both children and families

Legalizing the recreational use of marijuana sends a message to children and young people that drug use is socially and morally acceptable. As people of faith, we must speak out against this effort and the damaging effects its passage would have on the children and families of Arizona.

Studies have shown that adolescents who use marijuana have significant differences in brain structure and cognitive functioning compared to those who do not use marijuana and experience up to an eight-point drop in IQ. Furthermore, based on what happened in just two years after Colorado legalized marijuana, it is estimated that if Arizona passes this measure, tens of thousands of additional 8th graders here will smoke marijuana for the first time.

Marijuana-related traffic accidents and other problems are also likely to dramatically increase if recreational marijuana use is legalized. In Colorado for example, marijuana-related traffic deaths dramatically increased after recreational marijuana was legalized. Additionally, Colorado witnessed similar dramatic increases in hospitalizations and emergency room visits related to marijuana usage after recreational use was legalized.

In states that have legalized marijuana, there has also been an increase in the use of harder drugs like cocaine and heroin since marijuana was legalized, which only further increased

For the reasons mentioned above, and others, it is anticipated that legalizing the recreational use of marijuana in Arizona will lead to more abuse by teens, more emergency room visits, more traffic deaths, and more societal costs. Accordingly, due to the detrimental effect it would have on children, families, and all of society, we strongly oppose this dangerous proposal. *

Declaración de la Conferencia de Obispos Católicos de Arizona en Oposición a la Legalización de la Marihuana para uso Recreativo Votar NO a la Proposición 205

Los obispos de la Conferencia Católica de Arizona se oponen a la campaña para legalizar el uso recreativo de la marihuana en Arizona por considerarla dañina tanto para los niños como para las familias de Arizona.

Legalizar el uso recreativo de la marihuana enviaría a los niños y jóvenes el mensaje de que el uso de drogas es social y moralmente aceptable. Como gente de fe debemos hablar en contra de este esfuerzo y los efectos dañinos que su aprobación tendría en los niños y las familias de Arizona.

Los estudios han demostrado que los adolescentes que usan marihuana tienen grandes diferencias en su estructura cerebral y funcionamiento cognitivo comparados a aquellos que no usan marihuana, y experimentan una caída de hasta ocho puntos en su cociente intelectual (CI). Además, basados en lo que ha pasado en solo dos años después de la legalización de la marihuana en Colorado, se estima que, si Arizona aprueba esta medida, miles de niños del grado ocho fumaran marihuana por primera vez.

Los accidentes de tráfico relacionados con la marihuana y otros problemas también podrían aumentar drásticamente si se legaliza el uso recreativo de la marihuana. En Colorado, por ejemplo, las muertes por accidente de trafico ligadas a la marihuana aumentaron drásticamente luego que la marihuana fuese legalizada. Además, Colorado ha visto también aumentos drásticos en hospitalizaciones y visitas a las salas de emergencia relacionadas con el uso de la marihuana desde que fue legalizada.

En los estados que han legalizado la marihuana también ha habido un aumento en el uso de drogas más peligrosas como la cocaína y la heroína, lo cual ha tenido altos costos para la sociedad.

Por las razones ya mencionadas y otras, anticipamos que la legalización del uso recreativo de la marihuana en Arizona provocará su uso excesivo en adolescentes, más visitas a las salas de emergencia, más muertes por accidentes de tráfico, y más costos para la sociedad. Por eso debido al efecto perjudicial que tendría en los niños, las familias, y toda la sociedad, nos oponemos enérgicamente a esta peligrosa propuesta. *


